### **What does membership entail?**

Corporately, the membership has further powers defined by the company's Memorandum of Association.

Membership carries with it the obligation for each individual Member to guarantee that in the event of the company going into liquidation you will personally contribute to the payment of any outstanding liabilities to a maximum limit of £1 (one pound).

Currently **Minimum subscription is £30 per annum** and is used to fund the Bursary Account which provides those who are less advantaged a subsidised, if not free, holiday on the canals.
